Vendor acknowledges the management, the Sponsors, and their officers, agents or employees do not maintain insurance maintaining Vendor's property and that is the sole responsibility of the Vendor to obtain insurance for business interruptions, property damage, and other insurance covering such losses as Vendor may incur, and assume no responsibility for the safety of the properties of the Vendor's officers, agents, or employees from theft, damage by fire, accident of any other causes whatsoever. Vendor expressly agrees to save and hold harmless Musink Tattoo & Music Festival, c/o Goldenvoice LLC, AEG, its Management, Sponsors, their officers, its agents, employees and attendees, person and or property in connection with Vendor's use and occupancy of the exhibit space or participation at MusInk.

Vendor agrees to provide Commercial General Liability insurance and further agrees to include as part of its general liability insurance appropriate auto coverage (whether owned, hired or non-owned).
